**Explanation of Responses:**

1. Each restricted stock unit (RSU) represents the right to receive, following vesting, one share of Class A common stock of Mobileye Global Inc.

2. Unless earlier forfeited under the terms of the RSU, the RSU will vest as follows: (a) 40% of the RSUs vest and convert into common stock on the six-month anniversary of the grant date (which grant date is October 26, 2022), (b) 30% of the RSUs vest and convert into common stock on the twenty-month anniversary of the grant date and (c) 30% of the RSUs vest and convert into common stock on the thirty-two month anniversary of the grant date. If a vesting date falls on a non-business date, the next business date shall apply.
